Please include all relevant documentation, this may include public and products liability insurance certificates, food business registration or food safety supervisor certificates, organic certifications, farm, produce and stall photos etc.

This Application Form must also be accompanied by a **QPRC Food Business Registration Form**, this is a requirement of the Council. Where you need to stipulate the type of business you are you need to tick **'temporary market stall'**.
